Technology

The Office of Information Technology has relaxed its requirements for submitting an IT-10 for approval. In accordance with Information Technology Bulletin 02-02 Rev. 2, dated October 5, 2004, examples of IT expenses that no longer

require an approved IT-10 from OIT are:

- Continuation of an existing contract, multi-year lease, lease purchase, or finance agreement for equipment that has been approved by OIT through an IT Request.
- Hardware and software maintenance renewal contracts-Object Code 2820 Maintenance of Data Processing Equipment and Object Code 2825 Maintenance of Data Processing Equipment Software
- Acquisitions that were included in a previously approved IT Request (has been assigned a CIO Approval number) unless the project/initiative materially changes (i.e., change in technical approach or scope, increase in total costs by 15% or more).

OSP is requesting assistance from the agencies in these initiatives which exceed \$100,000.00 and require approval by this office. When submitting these initiatives for approval, please provide either the previous purchase order number, previous IT-10 >>

New Delegation of Authority for Telecommunications Requests

Effective February 1, 2005, the Office of Telecommunications Management (OTM) delegated "the development and review of technical specifications without prior written approval by OTM to agencies, *commensurate with their existing State Purchasing delegated purchasing authority, "for specific telecommunications supplies, equipment and services."* This new authority is also in accordance with the latest Small Purchases Executive Order issued by Governor Kathleen Blanco.

What's New in the Fuel Community



OSP has recently encountered a few new buzz words in the fuel community, "American Jobs Creation Act of 2004" and "Ultimate Vendor."

According to the IRS, "The American Jobs Creation Act" is broad and covers a variety of areas. As it applies to fuel, the Act is applicable only to the fuel supplier, not to State or Local entities.

Suppliers are paying excise tax when they purchase fuel from the terminals. State and local governments should not pay the excise tax, since the tax has already been paid by the suppliers. Suppliers may request reimbursement of the excise tax from the Department of Revenue. The supplier should provide an exemption certificate to the agency and request that the agency complete the form, sign it and return it to him.

An "Ultimate Vendor" is a designation given to a vendor who has applied for and received a 637 Number Registration from the IRS. This 637 number allows the vendor, each quarter, to apply to Revenue for reimbursement of excise tax paid for on and off road diesel. To receive a 637 registration and designation as an "Ultimate Vendor," the vendor must provide proof to the IRS that they are a fuel supplier.

Food Focus

LDAF Grading & Certification Requirements

All State Institutions are required to use only meat, poultry and seafood products that have met all of the Louisiana Department of Agriculture's (LDAF) requirements of the Grading and Certification Program. This means that all meat, poultry and seafood products accepted by state institutions must be certified by the LDAF Grading and Certification Program. A LDAF Certificate must be presented at the time of delivery, and each individual container must have the appropriate number of Louisiana Certification Stamps (Meat & Poultry-3, Seafood-2). Items applicable to Act 749 (see below) are excluded from these requirements.

All vendors, both in state and out of state, are required to make their products available to LDAF grading and certification service in an approved State of Louisiana facility for certification prior to shipment to the receiving agency. Once LDAF certifies the product based on specifications outlined in the agency's purchase order, an official Louisiana Agriculture Products Grade Certificate is issued to the vendor stating that the product meets or exceeds the purchase order specifications. Appropriate Louisiana Certification Stamps are applied at this time. Product shall be accepted at final destination only if the container has the appropriate number of

Louisiana Certification Stamps and is accompanied by a current State Certificate.

Meat Products

Applicable meat products produced and packaged outside of Louisiana may be purchased, provided that the USDA Meat Grading and Certification Branch certify the product and that the product meets the specifications of the Institutional Meat Purchase Specifications (IMPS) number associated with the product.

Seafood Products

Applicable seafood products produced and packaged outside of Louisiana may be purchased, provided that the product meets the applicable technical requirements of the U. S. Standards and Federal Specifications of the U. S. Department of Commerce Seafood Inspection Program.

Poultry Products

Applicable poultry products are certified based on specifications outlined in the purchase order issued by the purchasing agency.

Eggs

A Poultry Products Grading Certificate (PY-210) issued at the plant of origin or at destination inspection, unless at destination eggs are not over 10 days of age on Federal Stamp and PY-210, must accompany shell eggs. Upon arrival at purchasing agency, an Agricultural Products Grade Certificate issued by the Louisiana Department of Agriculture and Forestry must accompany eggs.

Act 749

Public entities that have been authorized by LDAF to conduct self-certification under LDAF regulations must inspect and certify all food products at the time of delivery. The entity shall provide sufficiently trained or experienced personnel to ensure that all products are inspected in accordance with LDAF regulations. Entities are to maintain certification logs acceptable to LDAF showing the self-certification of all food products received by the public entity. Each delivery of a food product shall be logged at the time of self-certification. Each logbook shall be made available for inspection when requested by authorized representatives of LDAF.

LaMAS Agreements and Homeland Defense



State Purchasing has developed LaMAS Agreements for use by State Agencies and Political Subdivisions, incorporating the needs of First Responders. LaMAS Agreements are state contracts established utilizing Federal Government General Services Administration (GSA) prices as a benchmark. The State requires

that the manufacturer sell the products through a Louisiana Distributor. Purchases from LaMAS Agreements in turn benefit our State economy.

LaMAS Agreements related to Homeland Defense are in place for the purchase of Automated External Defibrillators, Fire Trucks, Public Safety Vehicle Lighting and Sirens, and Specialty Vehicles including, HAZMAT Vehicles, Mobile Command Centers, SWAT Vehicles, Bomb Mitigation, Surveillance Vans, Fire and Arson Vehicles, and Mobile Crime Lab. These contracts include complex products for which the development of bid specifications would be difficult. Many of these contracts offer tiered pricing for multiple purchases.

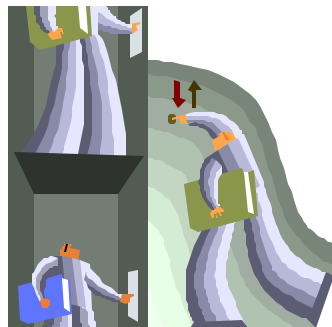

New WSCA Contracts were awarded effective January 1, 2005. All WSCA Contracts are catalog contracts which allow

you to go to the vendor's website to configure equipment and obtain an e-quote.

When obtaining an e-quote, be sure to stay within the LA WSCA Website or you will not be receiving the correct pricing. E-quotes should not contain any freight charges for routine shipping nor should any sales tax be charged. Shipping terms are F.O.B. Jobsite. When obtaining an e-quote, a copy must be retained with the purchase order. This will be the only document to verify prices for auditing purposes. Also, a copy of the e-quote should be sent with the purchase order to the vendor.

When processing the purchase order, all WSCA orders must be made to the OEM manufacturer. If an authorized reseller has helped with your selection of equipment, you may type the name of the reseller in the body of the purchase order. Authorized Resellers are listed on the OEM Website. Purchase orders are not to be issued to the reseller. All WSCA purchase orders must contain the Louisiana contract number and the WSCA number.

LONI - Currently in the procurement process is the Louisiana Optical Network Initiative (LONI) for the Board of Regents. LONI will create a state-wide higher education optical fiber infrastructure between universities across Louisiana that will allow for grid computing and other applications. High performance computers at the university sites will perform parallel processing allowing high speed and high capacity transport of technical research while sharing data bases along the routes. This is a high technology project that has the attention of higher education and computing communities across the nation. This is an example of an area where Louisiana is on the cutting edge.

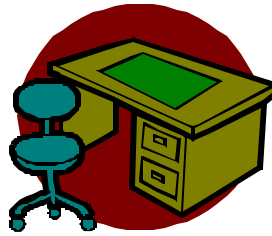


The Prescription Eyeglasses Contract No. 406100 has been awarded with an expiration date of January 31, 2006.
