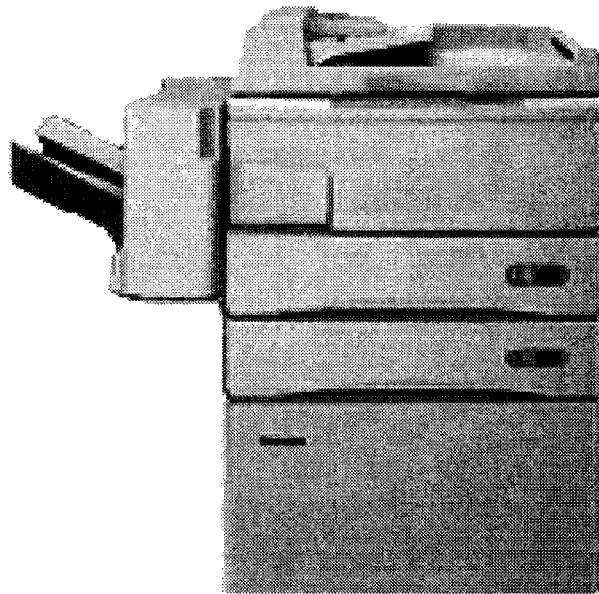

Attached for your convenience is basic information needed to assist you in selecting and processing requests for copiers that were awarded effective July 1, 2011.

Copier categories this year include purchase monochrome, rental monochrome, purchase color and rental color. All categories may be purchased with or without connectivity.

No wireless connectivity is allowed.

Vendors must adhere to all OIT policies and standards as well as any agency specific policies and standards for copiers with connectivity.

Vendors are to insure that agencies have obtained input from their IT Department prior to placing any orders for copiers with connectivity.

All agencies are required to work closely with their Information Systems personnel and the copier vendor(s) prior to placing orders for copiers with connectivity.

Agencies are allowed to change MCA lines, if applicable, within a given segment one time per contract year (12 month period) if deemed necessary.
