SUBJECT: Holiday Processing for December 2024

Attached is the calendar detailing the December 2024 processing schedule for LaGov HCM. It is imperative to note which holidays are on the LaGov HCM holiday calendar and which are not. Remember, holidays that do not appear on the LaGov HCM holiday calendar are not processed automatically.

Listed below is additional payroll processing information for December 2024.

- Requests for reversals for pay periods 25 2024 and prior must be sent to OSUP by Dec. 11, 2024 (received by noon).
- Off-cycle will close at 4:30 p.m. on Dec. 18, 2024 and will reopen on Thursday, Dec. 26, 2024.
- Off-cycle will close at 4:00 p.m. on Dec 26, 2024 and will remain closed until Jan. 2, 2025 due to year-end processing and holidays. Off-cycle is <u>ONLY</u> open on Thursday of this payroll week.
- Agencies should review the payroll reports that are available prior to payroll calc to ensure payroll for Dec. 27, 2024 is processed as accurately as possible. - No reversal requests will be accepted for the Dec. 27, 2024 payday. Any overpayments on this payday, or prior paydays, will have to be recouped from a future payment or through the claims process.

- Dec. 27, 2024 payday direct deposits will be transmitted on <u>Tuesday, Dec. 24,</u> <u>2024</u>, with a Dec. 27, 2024 settlement date.
- Dec. 27, 2024 payday payroll checks will be mailed by Friday, Dec. 27, 2024.
- Direct Deposits for Dec. 26, 2024 off-cycles will be transmitted on Dec. 26, 2024. Off-cycle checks saved on Dec. 26, 2024 will be mailed on Dec. 27, 2024.
- Off-cycle will reopen Thursday, Jan. 2, 2025 and will close at 4:30 p.m. Normal processing will resume on Friday, Jan. 3, 2025 after the annual W-2 jobs are complete.
