AN ACT

2	To enact R.S. 39:100.44.1, 100.44.2, and Subpart N of Part II-A of Chapter 1 of Subtitle I
3	of Title 39 of the Louisiana Revised Statutes of 1950, to be comprised of R.S.
4	39:100.51 through 100.59.2, relative to the disbursement of monies received from
5	the American Rescue Plan Act of 2021; to create funds for the deposit of federal
6	monies received from the American Rescue Plan Act of 2021; to create programs for
7	the administration of monies from the funds; to create and establish the Water Sector
8	Commission; to provide for the powers, duties, and authority of the Water Sector
9	Commission; to provide for the powers, duties, and authority of the Joint Legislative
10	Committee on the Budget; to authorize the Joint Legislative Committee on the
11	Budget to approve the transfer of monies received from the American Rescue Plan
12	Act of 2021 to certain funds; to provide for an effective date; and to provide for
13	related matters.
14	Be it enacted by the Legislature of Louisiana:
15	Section 1. R.S. 39:100.44.1, 100.44.2, and Subpart N of Part II-A of Chapter 1 of
16	Subtitle I of Title 39 of the Louisiana Revised Statutes of 1950, comprised of R.S. 39:100.51
17	through 100.59.2, are hereby enacted to read as follows:
18	§100.44.1. Louisiana Main Street Recovery Program; Louisiana Rescue Plan Funds;
19	Loggers Relief; Save Our Screens
20	A. Notwithstanding the provisions of R.S. 39:100.44, the treasurer shall
21	administer the Louisiana Main Street Recovery Program for grants to the Louisiana
22	Loggers Relief Program and the Louisiana Save Our Screens Program as provided
23	in this Section. The treasurer may utilize up to five percent of the monies in the
24	Louisiana Main Street Recovery Rescue Plan Fund for administration of the
25	programs. Notwithstanding any provision of law to the contrary, the treasurer may

1	enter into consulting services, professional services, and information and technology
2	services contracts for the purpose of the procurement of any goods or services
3	necessary to implement and expedite the distribution of funds as emergency
4	procurements exempt from the provisions of the Louisiana Procurement Code and
5	corresponding rules and regulations. The cost of such contracts shall be considered
6	administrative expenses.
7	B. Any business receiving funding from a program within the Louisiana
8	Main Street Recovery Program pursuant to this Section shall meet the following
9	criteria:
10	(1) Had a physical and active operation in Louisiana as of March 1, 2020.
11	(2)(a) For movie theaters, had fifty or fewer full-time equivalent employees
12	per location as of March 1, 2020.
13	(b) For other businesses, had fifty or fewer full-time equivalent employees
14	as of March 1, 2020.
15	(3) Filed Louisiana taxes for tax years 2019 and 2020.
16	(4) Experienced a revenue loss of ten percent or greater of gross revenue for
17	the period of January 1, 2020, through December 31, 2020, as compared to the gross
18	revenue of the business during the same period in 2019.
19	(5) Is in good standing with the secretary of state.
20	(6) Does not exist for the purpose of advancing partisan political activity.
21	(7) Does not directly lobby federal or state officials.
22	(8) Does not derive income from passive investments without active
23	participation in business operations.
24	C. Any grant award received pursuant to this Section combined with any
25	monies received pursuant to the Louisiana Main Street Recovery Program as
26	provided in R.S. 39:100.44, United States Small Business Administration-Guaranty
27	Paycheck Protection Program loan, and United States Small Business Administration
28	Economic Injury Disaster Loan Emergency Advance shall not exceed the amount of
29	revenue loss experienced by the business for the period of January 1, 2020, through
30	<u>December 31, 2020.</u>

D. Priority shall be given to businesses that previously submitted applications to the Louisiana Main Street Recovery Program as provided in R.S.

39:100.44 but whose applications were not considered due to exhaustion of monies in the Louisiana Main Street Recovery Fund.

E. The Louisiana Loggers Relief Program shall have priority for ten million

E. The Louisiana Loggers Relief Program shall have priority for ten million dollars of the money granted by the Louisiana Main Street Recovery Program.

Grants shall be distributed to eligible timber harvesting and timber hauling businesses impacted by COVID-19. Any grant received pursuant to this Subsection shall not exceed twenty-five thousand dollars per business. In addition to the criteria provided in Subsection B of this Section, a timber harvesting or timber hauling business shall meet all of the following criteria to be eligible to receive a grant:

- (1) Is assigned a North American Industry Classification System Code of 113310 or 484220.
 - (2) Is certified by the Louisiana Forestry Association as a master logger.
- (3) Is not a subsidiary of a business with more than fifty full-time equivalent employees, is not part of a larger business enterprise with more than fifty full-time equivalent employees, and is not owned by a business with more than fifty full-time equivalent employees.

F. The Louisiana Save Our Screens Program shall have priority for four million five hundred thousand dollars of the money granted by the Louisiana Main Street Recovery Program. Grants shall be distributed to eligible movie theater businesses impacted by COVID-19. Any grant received pursuant to this Subsection shall not exceed ten thousand dollars per movie screen located in Louisiana. Theatres with corporate ownership based outside of Louisiana shall use funds received pursuant to this Subsection for Louisiana-based screens and operations. In addition to the criteria provided in Subsection B of this Section, a business shall meet all of the following criteria to be eligible to receive a grant:

(1) Is a movie theater that has at least one permanent indoor auditorium for viewing films for entertainment by the general public who attend by the purchase of an individual ticket to view a specific non-adult-oriented film.

1	(2) Conducted regularly scheduled screenings in Louisiana in calendar year

3	(3) Is currently open and actively operating as of the effective date of this
4	Section.
5	(4) Was subject to limitations or restrictions as a result of Proclamation
6	Number 25 JBE 2020 or any subsequent gubernatorial proclamations related to
7	COVID-19.
8	G. The theater receiving the grant shall be the entity holding the occupational
9	license for the physical location of the applicable auditorium.
10	H.(1) There is hereby created in the state treasury, as a special fund, the
1	Louisiana Main Street Recovery Rescue Plan Fund, hereinafter referred to in this
12	Section as the "fund". The treasurer is hereby authorized and directed to transfer
13	<u>fourteen million five hundred thousand dollars from the Louisiana Rescue Plan Fund</u>
14	into the fund. Of the monies in the fund, ten million dollars shall be used for
15	economic support grants to eligible Louisiana timber harvesting and timber hauling
16	businesses and four million five hundred thousand dollars shall be used for economic
17	support grants to eligible movie theater owners in accordance with the provisions of
18	the Louisiana Main Street Recovery Program as provided in this Section.
19	(2) Monies in the fund shall be invested in the same manner as monies in the
20	state general fund. Interest earned on the investment of monies in the fund shall be
21	deposited in and credited to the fund.
22	(3) Any remaining balance in the fund on June 30, 2022, shall be transferred
23	to the Louisiana Rescue Plan Fund.
24	I. The legislative auditor shall consult with and provide to the treasurer
25	recommendations about requirements necessary for eligibility criteria and
26	verification of such criteria for the programs in this Section.
27	J. No grants shall be awarded pursuant to this Section after January 30, 2022.
28	§100.44.2. Port Relief; Small Business and Nonprofit Assistance
29	A.(1)(a) The division of administration, hereinafter referred to in this Section
30	as the division, shall administer the Port Relief Program. The program shall provide

funding to Louisiana port authorities for revenue loss and reimbursement of expenses related to COVID-19 and port security measures. The amount of total funding from the program for security measures shall not exceed five million dollars. Expenses submitted to but not reimbursed by the Coronavirus Local Recovery Allocation Program shall be eligible for reimbursement pursuant to the provisions of this program. In no event shall the total amount of an award made pursuant to the provisions of this program, when combined with all monies received by the port authority pursuant to the Coronavirus Aid, Relief and Economic Security Act (CARES), Coronavirus Response & Relief Supplemental Appropriations Act (CRRSA), the American Rescue Plan Act (ARP), and the Coronavirus Local Recovery Allocation Program, exceed the actual revenue loss, COVID-19 expenses, and maritime port security expenses incurred by the port authority, as determined in Item (c)(ii) of this Paragraph.

- (b) For purposes of this Section, "port authority" means the governing authority of any port area or port, harbor, and terminal district. The term "port authority" shall also include an entity that provides short line rail service for a port, harbor, or terminal district and has pledged its revenues to the indebtedness of the port, harbor, or terminal district.
- (c) Any port authority receiving funding pursuant to this Section shall meet the following criteria:
 - (i) Had a physical and active operation in Louisiana as of March 1, 2020.
- (ii) Experienced a revenue loss of gross revenue for the period of March 1, 2020, through June 30, 2021, as compared to the gross revenue that the port authority would have received during the same period pursuant to its financial plans.
- (d) The port authority seeking funding pursuant to this Section shall submit verification of revenue loss, COVID-19 expenses, and expenses related to maritime port security measures to the division of administration.
- (e) The division of administration is hereby authorized to promulgate emergency rules to provide for administration of this program and to establish an application period for awards pursuant to the provisions of this Paragraph.

(f) No funding shall be awarded pursuant to the provisions of this Paragraph until after the application period has closed. Thereafter, available funds shall be allocated on a pro rata basis to each port authority that qualifies for an award pursuant to the provisions of this Paragraph. If a port authority does not qualify for its full pro rata allocation, the remaining funds shall be aggregated for further pro rata distribution to remaining qualifying port authorities once all initial awards have been made. Any remaining balance after the second distribution shall be transferred to the Louisiana Rescue Plan Fund.

(g) The division of administration may utilize an amount not to exceed two hundred fifty thousand dollars collectively from the Louisiana Port Relief Fund and the Louisiana Tourism Revival Fund for administrative expenses associated with the Louisiana Port Relief Program and the Louisiana Tourism Revival Program.

B.(1) The Department of Revenue shall administer the Louisiana Small Business and Nonprofit Assistance Program. The Department may utilize up to five percent of the monies in the Louisiana Small Business and Nonprofit Assistance Fund for administration of the program. Notwithstanding any provision of law to the contrary, the Department may enter into consulting services, professional services, and information and technology services contracts for the purpose of the procurement of any goods or services necessary to implement and expedite the distribution of funds as emergency procurements exempt from the provisions of the Louisiana Procurement Code and corresponding rules and regulations. The cost of such contracts shall be considered administrative expenses.

- (2) The program shall provide grants to small businesses to provide workforce development activities and eligible nonprofit organizations, including public charities and faith-based organizations that provide social services to the broader community, to administer aid to individuals impacted by COVID-19. Any grant received pursuant to this Subsection shall not exceed twenty-five thousand dollars per small business or nonprofit organization.
- (3) Any small business or eligible nonprofit organization receiving funding pursuant to this Section shall meet the following criteria:

1	(a)(i) For a small business, is a corporation, limited liability company,
2	partnership, or sole proprietorship.
3	(ii) For a nonprofit organization, is a nonprofit corporation wholly owned by
4	a nonprofit corporation.
5	(b) Is currently open and actively operating as of the effective date of this
6	Section.
7	(c) Is in good standing with the secretary of state, if applicable.
8	(d) Filed Louisiana tax returns for tax years 2019 and 2020, if applicable.
9	(e) Does not exist for the purpose of advancing partisan political activity and
10	does not directly lobby federal or state officials.
11	(f) Is in good standing with the Internal Revenue Service and has filed the
12	Form 990 for tax year 2019 and 2020, if applicable.
13	(4) For nonprofit organizations, priority shall be given to organizations that
14	provide food, employment, and education assistance programs.
15	(5) For purposes of this Subsection, the following terms shall have the
16	following meanings:
17	(a) "Small business" shall mean a business with fifty or fewer full-time
18	equivalent employees.
19	(b) "Workforce development activity" shall mean any program, service, or
20	activity that involves workforce preparation or vocational skills training. It shall also
21	include any program, service, or activity that tends to improve an individual's
22	employment opportunities such as basic education, academic education, vocational,
23	technical, or occupational education, job readiness training, and job search training.
24	(6) Each small business or nonprofit organization that receives funds
25	pursuant to this Section shall enter into a cooperative endeavor agreement with the
26	Department of Revenue to ensure the funds are properly expended. The secretary
27	of the Department of Revenue may promulgate rules in accordance with the
28	Administrative Procedure Act to establish the policies and criteria regarding program
29	eligibility and any other matter necessary to carry out the intent and purposes of this
30	Section.

3	SUBPART N. LOUISIANA RESCUE PLAN FUND
4	§100.51. Louisiana Rescue Plan Fund; purpose
5	A. There is hereby created in the state treasury, as a special fund, the
6	"Louisiana Rescue Plan Fund", hereinafter referred to in this Section as the "fund".
7	The state treasurer is authorized and directed to deposit in and transfer into the fund
8	any federal monies allocated to Louisiana pursuant to the Coronavirus State Fiscal
9	Recovery Fund of the American Rescue Plan Act of 2021.
10	B.(1) The state treasurer is hereby authorized and directed to transfer five
11	hundred sixty-three million dollars out of the Louisiana Rescue Plan Fund into the
12	Construction Subfund of the Transportation Trust Fund in accordance with the
13	provisions of the American Rescue Plan Act of 2021 (P.L. 117-2) authorizing the use
14	of the Coronavirus State Fiscal Recovery Fund for the provision of government
15	services to the extent of a reduction in state revenues.
16	(2) The state treasurer is hereby authorized and directed to transfer fifteen
17	million dollars out of the Louisiana Rescue Plan Fund into the Legislative Capitol
18	Technology Enhancement Fund in accordance with the provisions of the American
19	Rescue Plan Act of 2021 (P.L. 117-2) authorizing the use of the Coronavirus State
20	Fiscal Recovery Fund for the provision of government services to the extent of a
21	reduction in state revenues.
22	(3) The state treasurer is hereby authorized and directed to transfer the
23	amount of ten million dollars out of the Louisiana Rescue Plan Fund into the Major
24	Events Fund.
25	(4) The state treasurer is hereby authorized and directed to transfer the
26	amount of five million dollars out of the Louisiana Rescue Plan Fund into the Health
27	Care Employment Reinvestment Opportunity (H.E.R.O.) Fund, in the event that
28	Senate Bill No.229 of the 2021 Regular Session of the legislature is enacted into law.
29	C. Monies in the fund shall be invested in the same manner as monies in the
30	state general fund. Interest earned on investment of monies in the fund shall be

credited to the fund. Unexpended and unencumbered monies in the fund at the end

2 of the fiscal year shall remain in the fund. 3 D. Monies in the fund shall be allocated as provided in this Subpart and may 4 be appropriated for the Clearing Account of the Unemployment Compensation Fund 5 pursuant to R.S. 23:1491. 6 E. If the legislature is not in session, the Joint Legislative Committee on the 7 Budget is authorized to appropriate monies from the Louisiana Rescue Plan Fund or 8 any of the funds created pursuant to this Subpart by approving a budget adjustment 9 by BA-7. Any such appropriation shall be consistent with guidance promulgated by 10 the United States Treasury. The committee is further authorized to approve the 11 transfer of funds between any of the funds created pursuant to this Subpart by 12 approving a budget adjustment by BA-7. Pursuant to approval of a BA-7, monies 13 in the fund may be used to provide funding for infrastructure projects administered 14 by the Department of Transportation and Development. 15 §100.52. Water Sector Fund 16 A. There is hereby created in the state treasury, as a special fund, the Water 17 Sector Fund, hereinafter referred to in this Section as the "fund". The treasurer is 18 hereby authorized and directed to transfer three hundred million dollars from the 19 Louisiana Rescue Plan Fund into the Water Sector Fund. 20 B. Monies in the fund shall be invested in the same manner as monies in the 21 state general fund. Interest earned on the investment of monies in the fund shall be 22 deposited in and credited to the fund. 23 C. Monies in the fund shall be used to provide grant funding for repairs, 24 improvements, and consolidation of water systems and sewerage systems and repairs 25 and improvements necessitated by storm water pursuant to the Water Sector Program 26 as provided in R.S. 39:100.56. 27 §100.53. Granting Unserved Municipalities Broadband Opportunities Fund 28 A. There is hereby created in the state treasury, as a special fund, the 29 Granting Unserved Municipalities Broadband Opportunities (GUMBO) Fund, 30 hereinafter referred to in this Section as the "fund". The treasurer is hereby

1	authorized and directed to transfer ninety million dollars from the Louisiana
2	Coronavirus Capital Projects Fund into the fund.
3	B. All unexpended and unencumbered monies in the fund at the end of the
4	fiscal year shall remain in the fund. Monies in the fund shall be invested in the same
5	manner as monies in the state general fund. Interest earned on the investment of
6	monies in the fund shall be deposited in and credited to the fund.
7	C. Monies in the fund shall be used to provide grants to help fund broadband
8	access in rural and disadvantaged areas pursuant to the provisions of the Granting
9	Unserved Municipalities Broadband Opportunities program established by law.
10	§100.54. Louisiana Tourism Revival Fund
11	A. There is hereby created in the state treasury, as a special fund, the
12	Louisiana Tourism Revival Fund, hereinafter referred to in this Section as the "fund".
13	The treasurer is hereby authorized and directed to transfer seventy-seven million
14	five-hundred thousand dollars from the Louisiana Rescue Plan Fund into the fund.
15	B. All unexpended and unencumbered monies in the fund at the end of the
16	fiscal year shall remain in the fund. Monies in the fund shall be invested in the same
17	manner as monies in the state general fund. Interest earned on the investment of
18	monies in the fund shall be deposited in and credited to the fund.
19	C. Monies in the fund shall be utilized to support the efforts of state, local,
20	and regional tourism entities to revive tourism in Louisiana by investing in programs
21	focused on marketing and promoting Louisiana as a destination for in-state and
22	out-of-state travel activity.
23	D. Monies in the fund shall be distributed as follows: sixty million dollars
24	shall be used for the Louisiana Tourism Revival Program as provided for in R.S.
25	39:100.55 and seventeen million five-hundred thousand dollars shall be appropriated
26	to the Department of Culture, Recreation and Tourism for the Marketing Program.
27	§100.55. Louisiana Tourism Revival Program
28	A. The Louisiana Tourism Revival Program is established to provide grants
29	to local and regional tourist commissions for marketing and promoting Louisiana as

1	a tourism destination for in-state and out-of-state travel activity. The division of
2	administration shall administer the program.
3	B. The division of administration shall establish a program portal in which
4	applications shall be submitted, and the division shall publish information on the
5	program. The program portal page shall be operational no later than August 31,
6	<u>2021.</u>
7	C. In order to qualify to receive a grant award, the recipient shall be an
8	official tourism commission, convention and visitors bureau, or official destination
9	marketing organization.
10	D. The division of administration shall submit a plan for the administration
11	and structure of the program to the Joint Legislative Committee on the Budget by
12	July 31, 2021, for review and approval at the monthly August meeting. No grants
13	shall be awarded prior to Joint Legislative Committee on the Budget approving the
14	plan submitted by the division of administration.
15	E. The division of administration may utilize an amount not to exceed two
16	hundred fifty thousand dollars collectively from the Louisiana Port Relief Fund and
17	the Louisiana Tourism Revival Fund for administrative expenses associated with the
18	Louisiana Port Relief Program and the Louisiana Tourism Revival Program.
19	§100.56. Water Sector Program
20	A. As used in this Section, the following terms shall have the following
21	meanings:
22	(1) "Commission" shall mean the Water Sector Commission.
23	(2) "Committee" shall mean the Joint Legislative Committee on the Budget.
24	(3) "Division" shall mean the division of administration.
25	(4) "Fund" shall mean the Water Sector Fund.
26	B.(1) The Water Sector Commission is hereby established to review
27	applications submitted pursuant to the Water Sector Program and make
28	recommendations for funding to the Joint Legislative Committee on the Budget.
29	(2) The commission shall be comprised of the following members:

1	(a) Five members of the House of Representatives appointed by the speaker
2	of the House of Representatives.
3	(b) Five members of the Senate appointed by the president of the Senate.
4	(3) A Senate member of the commission and a House member of the
5	commission shall serve as co-chairmen of the commission.
6	(4) A quorum of the commission shall be six members. Any
7	recommendations made by the commission shall require a quorum for approval.
8	(5) The staffs of the Senate, House of Representatives, and legislative fiscal
9	office shall provide staff support and otherwise assist the commission as requested
10	by the commission.
1	C. The Water Sector Program is hereby established to provide grant funding
12	for repairs, improvements, and consolidation of community water and sewer

24	D.(1) The commission shall hold its first meeting no later than June 30,
25	2021. At its first meeting, the commission shall issue directives to the division to
26	utilize in the development of the guidance required in Paragraph (2) of this
27	Subsection.
28	(2) The division shall promulgate guidance for the administration of the
29	program. The guidance shall include application requirements, deadlines for
30	application submissions and approval, criteria for ratings, and a process for

1 prioritizing critical infrastructure needs. The Administrative Procedure Act, R.S. 2 49:950 et seq., shall not apply to guidance promulgated pursuant to this Section. No 3 later than July 15, 2021, the division shall submit the proposed guidance to the 4 commission for review and approval. Any changes to the guidance shall require 5 approval by the commission. 6 E. In addition to the guidance provided for in Subsection D of this Section, 7 the division shall submit a proposal outlining administrative costs for the program 8 to the commission for review and approval prior to implementing the program no 9 later than July 15, 2021. The commission shall review the proposed administrative 10 costs and make a recommendation to the Joint Legislative Committee on the Budget 11 for funding for administrative costs. The committee shall review the 12 recommendations submitted by the commission and approve administrative costs for 13 the program. 14 F. Notwithstanding any provision of law to the contrary, the division may 15 enter into consulting services, professional services, and information and technology 16 services contracts for the purpose of the procurement of any goods or services 17 necessary to implement and expedite the distribution of funds as emergency 18 procurements exempt from the provisions of the Louisiana Procurement Code and 19 corresponding rules and regulations. The cost of such contracts shall be considered 20 administrative costs. 21 G. Each grant recipient shall be required to provide matching funds unless 22 the commission recommends waiving the match requirement. 23 H. The division shall begin accepting applications no later than August 1, 24 2021. The applications shall include the following, at a minimum: 25 (1) The amount of grant funding requested.

(2) The amount and proposed source of funding for the proposed match.

(3) Proposals for repairs, improvements, or consolidation with neighboring

(4) Assurance the entity will comply with the rate determination of the rate

2	study completed by a third party chosen by the division prior to release of funds for
3	construction and permission to bid.
4	(5) A certification from the local governing authority that operates the
5	system or the water system operator that funding from the Coronavirus Fiscal
6	Recovery Fund of the American Rescue Plan Act of 2021 is being used as a source
7	of funding for the required match or explanation of legitimate cause that precluded
8	the use of those funds for the match.
9	I. Within forty-five days of the end of the application period, the division
10	shall submit the working panel's ratings of proposed projects and recommendations
11	for funding for the projects to the commission. The working panel's
12	recommendations to the commission shall include recommendations for utilization
13	of existing funding sources including the Drinking Water Revolving Loan Fund,
14	Clean Water State Revolving Fund, and Community Water Enrichment and Other
15	Improvements Fund.
16	J. The commission shall review the ratings and recommendations submitted
17	by the working panel. The commission shall submit its recommendations for
18	projects to receive monies from the fund and funding amounts to the Joint
19	Legislative Committee on the Budget. The recommendations shall include proposed
20	matching funds unless the commission recommends a waiver of matching funds or
21	decreased match for any project based on the determination that the local governing
22	authority or water system is unable to provide the match.
23	K. The committee shall review the recommendations submitted by the
24	commission and have final approval of funding for projects. No monies shall be
25	expended from the fund without approval of the Joint Legislative Committee on the
26	Budget.
27	L. Beginning January 1, 2022, the division shall submit a quarterly
28	construction progress report for projects that received funding approval to the Joint

Monies in the fund shall be used to assist in repairing structural damages caused by the 2020 hurricane season in Southwest Louisiana.

B. The treasurer is hereby authorized and directed to transfer thirty million dollars from the Louisiana Rescue Plan Fund into the fund in accordance with the provisions of the American Rescue Plan Act of 2021 (P.L. 117-2) authorizing the use of the Coronavirus State Fiscal Recovery Fund for the provision of government services to the extent of a reduction in state revenues. Monies in the fund shall be invested in the same manner as monies in the state general fund. Interest earned on the investment of monies in the fund shall be deposited in and credited to the fund. §100.59.2. Capital Outlay Relief Fund

A. There is hereby created in the state treasury, as a special fund, the Capital

Outlay Relief Fund hereinafter referred to in this Section as the "fund". Monies in
the fund shall be used for capital outlay projects.

B. The treasurer is hereby authorized and directed to transfer thirty-five million dollars from the Louisiana Rescue Plan Fund into the fund in accordance with the provisions of the American Rescue Plan Act of 2021 (P.L. 117-2) authorizing the use of the Coronavirus State Fiscal Recovery Fund for the provision of government services to the extent of a reduction in state revenues. Monies in the fund shall be invested in the same manner as monies in the state general fund. Interest earned on the investment of monies in the fund shall be deposited in and credited to the fund.

Section 2.(A) This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.
