PROGRAM MISSION:

The mission of the Office of Worker's Compensation Administration (OWCA) is to ensure fair and efficient processing of injured workers' disputed claims and prosecuting fraud in accordance with state statutes. This includes maintaining Medical Treatment Guidelines and resolving medical necessity legal disputes. The OWCA also promotes workplace safety by educating and guiding employers and employees in the adoption of comprehensive health and safety policies, practices, and procedures. Additionally, the office is responsible for the collection of associated fees.

PROGRAM GOALS:

- I. To administer a financially sound program that administers the resolution of workers' compensation disputes in an efficient, timely, and impartial manner.
- II. To control medical cost.
- III. To maximize the quality of care received by workers injured on the job.
- IV. To swiftly respond to all requests for safety and health consultation services from Louisiana employers.
- V. To ensure compliance with duty to maintain workers' compensation coverage and protect against fraudulent activity.
- VI. Ensure Second Injury Board reimbursement for qualifying claims in a timely manner and maintain adequate funding.

PROGRAM ACTIVITY:

PROGRAM NUMBER AND NAME: 4742 - Office of Workers Compensation Administration

Fraud and Compliance Section – This activity serves as the enforcement arm of the OWCA. Its primary responsibilities include investigating fraudulent activities involving any party associated with the Louisiana workers' compensation system and ensuring that all employers within the state comply with the legal requirement to maintain appropriate workers' compensation coverage. This section conducts investigations based on allegations of fraud received through tips from the public, insures, employers, law enforcement, or the OWCA Hearings Division. It also performs audits of self-insured employers to verify compliance with workers compensation laws and regulations.

- Hearings This activity is responsible for conducting hearings on claims related to workers' compensation benefits, disputes over entitlement to benefits, and requests for other relief under the Louisiana Workers' Compensation Act. Disputed claims may be initiated by employees, employers, insurers, or healthcare providers. Once a claim is filed, either party may request a mediation conference with a mediator from the Louisiana Workforce Commission (LWC) or a private mediator, with the goal of reaching an informal resolution. If the parties agree to a settlement, a compromise or lump-sum settlement is formalized and approved by a Workers' Compensation Judge. If mediation does not resolve the dispute, the case proceeds to trial before a Workers' Compensation Judge, who renders a final decision. A claim is concluded once a settlement is reached or a final judgment is issued.
- Occupational Safety and Health Act (OSHA) -This activity imparts consultation, regulation, enforcement, and educational information to employers, regarding State of Louisiana and OSHA guidelines and regulations, in an effort to provide Louisiana workers and employers with a healthy and safe work environment. Hazards reviewed include all physical, chemical, biological, ergonomic, documentation, and safety/health-related hazards identified during on-site consultations.
- Medical Services This activities include a review of the medical treatment guidelines outlined in LAC Title 40, in preparation for updates to the guidelines by the Medical Advisory Council in late 2025. Additionally, the program reviews medical disputes regarding the necessity of medical treatment and compliance with the Medical Treatment Guidelines, and appoints Second Medical Opinion physicians for non-litigated claims.

PROGRAM AUTHORIZATION:

Louisiana Revised Statutes 23:1471; Federally mandated by the Wagner - Peyser Act of 1933, the Social Security Act of 1935, and the Federal Unemployment Insurance Tax Act (FUTA).

PROGRAM MISSION:

The mission of the Office of Unemployment Insurance Administration is to support eligible individuals with temporary income assistance as they pursue meaningful and sustainable employment.

PROGRAM GOALS:

- I. To provide financial security to unemployed workers through timely and accurate payment of Unemployment Compensation Benefits funded by employers' payments of quarterly unemployment taxes.
- II. To administer the Unemployment Insurance Trust Fund supported by employer taxes to pay Unemployment Compensation Benefits to eligible unemployed workers.

 III. To administer unemployment benefits while ensuring eligible recipients receive support promptly while maintaining the integrity and accuracy of the program to prevent fraud and errors.

PROGRAM ACTIVITY:

•

Unemployment Benefit Payments: This activity pays unemployment benefits to unemployed/underemployed individuals in accordance with provisions of the Louisiana Employment Security Law. Funds come from the Unemployment Insurance (UI) Trust, financed by quarterly payroll taxes paid by Louisiana employers. Administrative responsibility includes the determination of monetary entitlement, weekly eligibility, deductible income, and non-monetary eligibility, including disqualifications for voluntary leaving and misconduct discharges. Initial and weekly claims are filed over the Internet or by telephone through the UI Call Center.

• Unemployment Insurance Taxes: This activity registers employers, assigns tax rates, and collects taxes from employers subject under Louisiana Employment Security Law and liable to pay UI taxes. It is a business tax on an employer's payroll and not a deduction from employee wages. Employers are responsible for submitting quarterly employee payroll data along with the payment of UI taxes. Taxes are deposited into the UI Trust Fund within three (3) days of receipt, and are used to pay unemployment compensation to the unemployed. The payroll data is utilized in determining the monetary eligibility of unemployment claims. Compliance audits are conducted to ensure employers are reporting properly, obtain missing wage data, and to collect delinquent taxes.

Unemployment Insurance Fraud Detection and Investigation: This activity utilizes several cross match measures including but not limited to: Identity Verification, National Directory of New Hire, State Directory of New Hire, Incarceration databases, Office of State Payroll, Social Security, Department of Health and Hospitals death index, In-state and Out-of-state wage cross match, tips/leads, other state UI systems, the Integrity Data Hub, data analysis, and several additional resources.

- Vocational Rehabilitation Services for Career Development and Employment: This activity provide employment services to individuals with disabilities, including Pre-Employment Transition Services (Pre-ETS) for students, to support economic independence and successful employment in demand-driven occupations.
- Randolph Sheppard Business Enterprise: This activity provide entrepreneurial opportunities for individuals who are legally blind to operate and manage food service businesses in federal, state, or municipal facilities. The program aims to enhance economic self-sufficiency and reduce reliance on public assistance.
- Independent Living Older Blind and Part B: This activity supports individuals with significant disabilities—particularly older individuals who are blind—in maintaining or improving their independence at home and in the community.
- Labor Statistics: This activity produce and disseminate labor force statistics, employment projections, and occupational data for Louisiana's workforce development and economic planning systems. Supports stakeholders through actionable labor market intelligence derived from federal programs and state-level analysis.


