The IRS has changed the Section 45Q Credit such that a larger credit will be given for each metric ton of carbon dioxide that is injected underground for permanent storage under this program but has stated that construction of these wells must begin before January 1, 2024 to be eligible for the credit. As a result, many operators are planning on permitting injection wells in Louisiana by 2024. The Office of Conservation - Injection and Mining Division currently has primacy from the USEPA for Class I, II, III, IV, and V wells, and recently has been granted primacy for Class VI to protect the health, safety, and welfare of the public in a consistent manner with all other injection wells in the State of Louisiana. In the Louisiana Regular Session of 2009, House Bill 661 was passed in support of the Class VI primacy effort. HB 661 enacted R.S. 19:2(12) and Chapter 11 of Title 30 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 30:1101 through 1111, relative to the storage of carbon dioxide. The proposed Class VI Injection Wells rule is at least as stringent as the corresponding federal rule (40 CFR 124, 144, 145, and 146) and also incorporates the enactments of HB 661.

There are many vehicles in our fleet that are older, have increasing maintenance costs, and are unreliable. In our request 13 vehicles will be used by our UIC and CES field inspectors and agents to conduct field inspections, surveillance, and enforcement activities in geographically remote areas and require reliable vehicles. Of these 13 vehicles 3 of the vehicles will be 60% federally funded and 2 of vehicles will be 87.5% federally funded by direct federal grants to Conservation and Energy. Conservation and Energy also has a vehicle to be replaced due to an issue with the dual battery system. The batteries have been replaced multiple times since the vehicle was purchased including an eighteen-month time frame where this occurred on four separate occasions. Employees have attempted to use the vehicle for site visits, meetings, etc. and the vehicle failed to start. In addition, there is a safety recall in place that pertains to the vehicle's hydraulic control unit (HCU)/anti-lock system (ABS) module. The recall references brake light illumination problems. To date, with regards to a resolution for the recall there is no remedy in place. Other issues associated with the vehicle include fuses being blown while the vehicle is off and parked. Due to the reliability and safety issues associated with the vehicle staff elected not to use it.

Department of Conservation and Energy Water Resource Division

This memorandum highlights several factors warranting a request for funding and personnel to support development of a comprehensive water resource management program within the Department of Conservation and Energy, as directed by the legislature on behalf of the people of Louisiana.

In a 2020 report to former Senate President Patrick Cortez and former House Speaker Clay Schexnayder, the Louisiana Legislative Auditor noted concerns with sustainability and oversight of Louisiana's water resources and suggested the need for state and local entities to be given better water resource management authorities. The report also noted that "since 1956, Louisiana has spent at least \$5.3 million for a total of 12 studies on water resources and management strategies – many of which recommended that the state develop a comprehensive management plan. However, Louisiana still does not have such a plan."

During the 2025 Regular Session, the Louisiana Legislature took an unprecedented step to address this legacy issue through passage of Act 458 (SB 244 – effective October 1, 2025), which declares management, protection and development of Louisiana's water resources to be essential for public welfare, economic prosperity and environmental sustainability and directs the Department of Conservation and Energy (C&E) to establish a comprehensive water resource management program that takes into consideration the requirements, needs, and obligations of all water stakeholders in the state. In support of this directive, the Act gives the State the exclusive jurisdiction over management of its water resources and mandates that C&E develop, implement, and periodically update a comprehensive statewide water resource management plan. *See* Act 458, 2025 Regular Session, p. 90 through 95.

The legislature's grant of jurisdiction was the first foundational step to development of the regulatory program envisioned by the 2020 Legislative Audit report. But as the report suggests, there is no precedent for centralized management and oversight of Louisiana's water resources—C&E does not have any basic regulations, legacy systems, or personnel to carry out what will be a very significant, labor-intensive, long-term task. Solar Wind Positions - Total 4 T.O. (Two Statewide Program Manager 2, Accountant 4, and Engineer 6

Act 279 expands the Department of Conservation & Energy's authority over solar generation and renewable energy storage facilities, creating new permitting, enforcement, and public-engagement responsibilities. The Act adds duties requiring new capacity in program management, engineering review, and financial compliance including the review and tracking of letters of clearance, enforcement of setback and permit conditions, development of administrative rules, and oversight of public hearings. These functions demand interdisciplinary coordination and technical expertise not available under current staffing levels. To meet these statutory mandates, the Department requires four additional full-time positions: Two Statewide Program Manager 2 to oversee implementation of solar and storage permitting programs, coordinate legal, enforcement, and financial-security functions, and manage required public hearings. Engineer to conduct technical reviews of permit applications, decommissioning plans, and risk assessments for new facility types. Accountant 4 to review, validate, and monitor financial-security instruments, ensuring compliance with decommissioning and liability requirements. These positions are essential to fulfill Act 279 requirements, ensure timely and compliant permit processing, and protect the State's fiscal and environmental interest through proper oversight of large scale solar and energy storage projects.

Office of State Resources – Total 5 T.O. (Two Attorney 3, Three Auditor 3)

Justification for Two Attorney 3 Positions

We are requesting TO for two (2) Attorney 3 positions that will play an instrumental role in the collection of an estimated \$54.8 million due and payable to the State through mineral leases issued by the State Mineral and Energy Board. The recoverable funds fall into two categories:

- a. Acreage Conflict and Title Dispute Funds some state mineral leases are subject of competing land ownership claims from third-parties. When this takes place, standard procedure in the oil and gas business is for the party producing the minerals to put all payable royalties into suspense (collecting very little interest, if any), until the conflicting claimants settle their dispute by determining ownership of the land and minerals, and thus the proper allocation of royalty dollars. Such disputes are typically resolved through litigation or out-of-court settlement. Approximately \$42.7 million in royalties payable to the State remain in escrow or suspended accounts due to unresolved acreage ownership conflicts, particularly within the Red River region intersecting the Haynesville Shale.
- b. Royalty Exception Disputes the Income Division of DCE's Office of State Resources performs field audits—in which auditors' survey records of State mineral lessees to confirm that proper royalty amounts were paid to the State. When underpayments are identified, our audit team advises the state lessee of its findings, and legal staff places the lessee on demand for payment. State lessees often object to audit findings, which in turn requires legal negotiation or litigation for resolution. Current uncollected receivables as a result of open audits and exception disputes amount to approximately \$12.1 million.

The significant backlog of nearly \$55 million is attributable in large part to a lack of adequate legal support to manage and process these claims. The attorneys requested herein are intended to fill that gap—by inventorying, prioritizing, and resolving outstanding disputes as efficiently as possible

while advocating for the best interests of the State. The positions represent clear potential for greater-than-average return on investment, and offer the opportunity to strengthen the Department's alignment with statewide goals for reduced reliance on general fund.

The Attorney 3 positions will be responsible for: organizing, prioritizing, and resolving outstanding disputes through an organized dispute resolution system. Internal work will be coordination with State Resources staff and review of case files and comparison of their respective amounts in controversy, likelihood of recovery, and procedural history. External operations will consist primarily of negotiation and advocacy—working with state lessees, third-party land claimants, and their attorneys towards resolution of each outstanding dispute.

Justification for Three Auditor 3 Positions – Field Audit Section

The addition of three Auditor 3 positions—two based in Houston and one based in Baton Rouge—is essential to increase audit capacity and improve the timeliness of royalty underpayment recoveries for the State Mineral and Energy Board (SMEB).

Currently, the Field Audit Section's limited staffing restricts the number of audits that can be performed each year. Over the past five fiscal years, only 67 audits have been completed, averaging 13 audits per year. Based on filled positions, this equates to approximately 1.3 audits per auditor annually. Each new auditor requires a two- to three-year training period, after which they can conduct audits independently. Increasing staff now ensures the Section can maintain continuous audit coverage and mitigate the impact of retirements or vacancies.

With the addition of three Auditor 3 positions, the Department projects the capacity to complete 84 audits over the next five fiscal years—a 25% increase—resulting in faster identification and recovery of royalty underpayments owed to the State.

This staffing enhancement directly supports the Department's Performance Indicators:

- PI 3428: Percentage of royalties audited to total royalties paid
- PI 23114: Percent of repeat findings
- **PI 3429:** State audit exceptions billed (millions)

They cannot be lawfully destroyed, and must remain accessible, legible, and reliable. The microfiches in our holdings are on cellulose acetate film base, which is susceptible to a chemical degradation process known as vinegar syndrome (or acetate film base degradation). The process produces acetic acid (hence the ivinegar smell), causes the film to shrink, warp, curl, and become brittle, and eventually causes the image emulsion to delaminate or crack. Once degradation begins, it cannot be reversed ó freezing or cooler storage can only slow the progression. The deterioration is autocatalytic: as the film decays, acidic byproducts can accelerate further decay and even infectî nearby films. Over time, microfiche impacted by vinegar syndrome becomes unreadable or physically unusable ó edges curl, emulsion flakes off, images fade or distort. If we delay action, portions (or entire records) may become irrecoverable.
