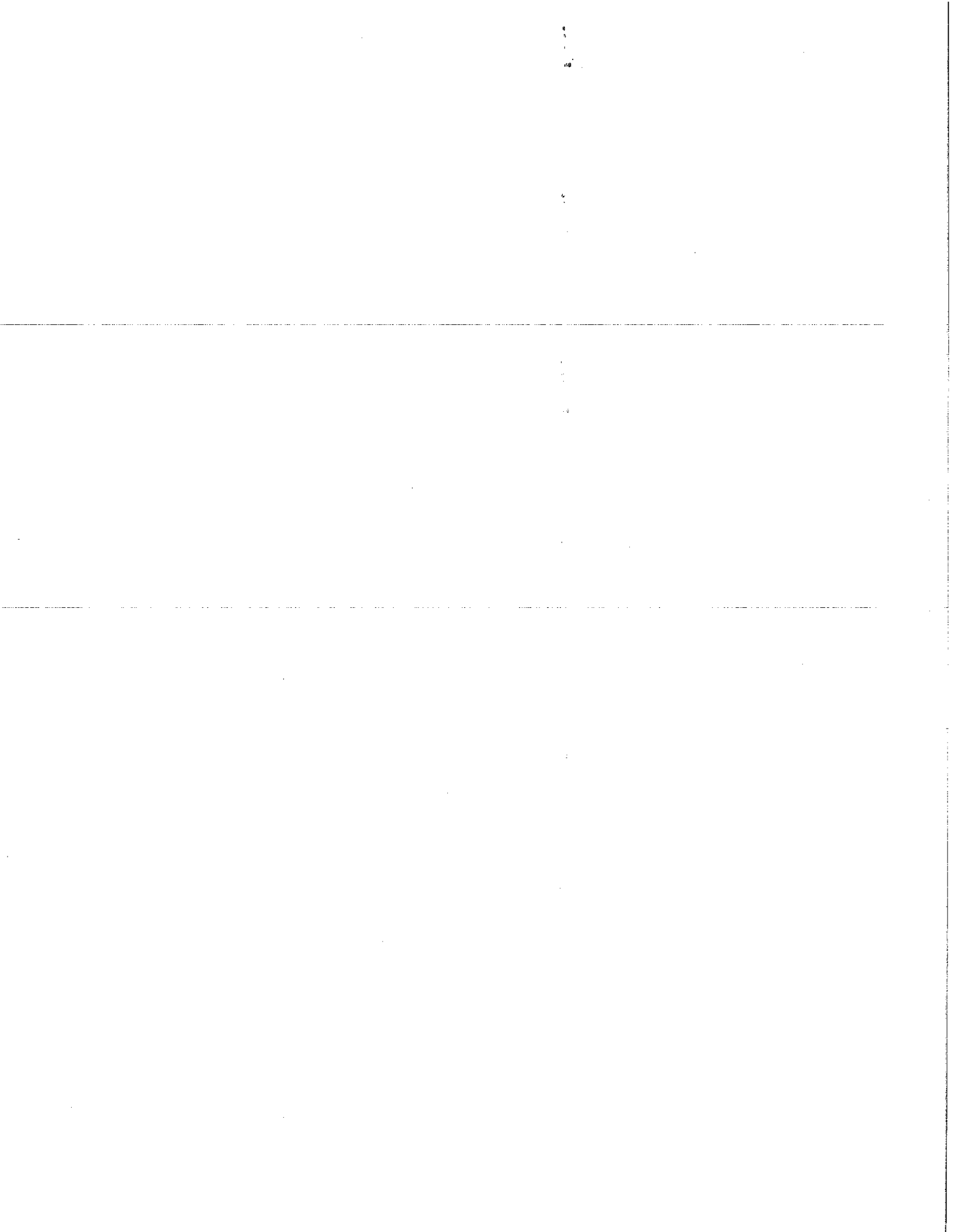

## QUESTIONNAIRE ANALYSIS

### GENERAL PURPOSE

This BA-7 is to budget an appropriation of the Geaux Teach Fund to the Board of Regents from dollars received via Act 463 of the 2022 Regular Legislative Session. The Act was signed after the General Appropriations Act (Act 199), and therefore the initial appropriation to the fund was allocated the Department of Education. However, as per Act 463, the Geaux Teach fund is to be available "exclusively" for the Office of Student Financial Assistance (LOSFA) program within the Board of Regents agency. Approval of this BA-7 is necessary to distribute said dollars, and the increase in Interagency Transfer authority is needed to receive funding from the Department of Education.

### REVENUES

The source of funding is the Geaux Teach Fund created by Act 463 of the 2022 Regular Legislative Session. Per Act 167 of the 2022 Regular Legislative Session, \$5 million was allocated to the Geaux Teach Fund; this BA-7 increases budget authority for Interagency Transfer by \$1,250,000 to receive the initial support dollars.

### EXPENDITURES

The net increase will allow the LOSFA, via the Board of Regents, to distribute the Geaux Teach funds in accordance with Act 463. The fund expenditures are restricted to provide scholarships to full-time undergraduate students enrolled in teacher education programs with the intent of becoming a certified teacher, and up to 20 percent is to be used for those persons enrolled in certified alternative teacher certification programs, with rules and regulations as determined by LOSFA. These scholarships will cover the costs of tuition, fees, and textbook and instructional materials.

Of the \$1.25M allocation, \$37,500 will be used for operational expenses in accordance with the three percent allowed per Act 463. The remaining \$1.2M allocated for institutional scholarships. As per the legislation, 20%, or \$242,498 will be distributed to the alternative teacher certification programs and \$969,984 to the teacher education undergraduate programs. The amount of the individual awards is dependent upon the number of students enrolled in each institution's teacher education program. The distribution of funds will be of equitable amounts for the initial year, with a review in FY24 to determine the best allocation process moving forward. The rules have been promulgated by the LOSFA Advisory Board and are up for review by the Board of Regents.
